Vested shares will be issued to the reporting person as soon as practicable after the vesting date.

- The price reported in Column 4 is a weighted average price. These shares were sold in multiple transactions at prices ranging from \$65.03 to \$65.40, inclusive. - This option becomes exercisable in three equal annual installments on each of February 23, 2019, February 23, 2020 and February 23, 2021.
