The members of the investment committee disclaim beneficial ownership, except to the extent of their respective indirect pecuniary interest in the Issuer. Mr. Goldstein is a managing director of Hellman & Friedman LLC, but he is not a member of the investment committee. Mr. Goldstein disclaims beneficial ownership of the common stock held by the Funds except to the extent of his pecuniary interest therein.
